MASTER OF SAFETY CERTIFICATE PROGRAM
is right for you.

The Master of Safety Certificate program is an educational achievement in the workplace safety industry designed specifically for those who are committed to improved safety performance for themselves, their co-workers and their business. As a Master of Safety Certificate holder, you'll gain the information you need to develop and implement effective safety and health programs at your business, as well as provide your employees with a safe workplace that meets government standards and program criteria.

Earning the Master of Safety Certificate requires extra effort but it's worth it when you see safety improvements you've implemented begin to take hold ...

WHAT DOES IT TAKE?

Registration form: Complete the registration form provided by the NDSC so we can keep a record of the courses you've taken and credits earned.

100 credits: Certification is earned by completing courses conducted by the NDSC, which total 100 credits. Credits correspond to the number of hours for each course. If you've taken courses conducted by the NDSC prior to submitting your registration, those courses can be counted as credits toward your certificate, if you have records.

Of the 100 credits to be earned, the following courses/credits are REQUIRED:

Supervisor's Safety Development Program: This two-day, 16-hour course counts for 16 credits toward the 100 required.

Traffic Safety Course: Those earning their Master of Safety Certificate must complete a traffic safety course and may choose from the following, depending on interest or need:

- Defensive Driving Course, online – 4 credits
- Defensive Driving Course DDC4 – 4 credits
- Defensive Driving Course Alive at 25 – 4 credits
- DDC4 Instructor Development Course – 24 credits*
- DDC Alive at 25 Instructor Development Course – 24 credits*

CPR/AED/First Aid: Those earning their Master of Safety Certificate must complete a CPR/AED/First Aid course and may choose from the following, depending on interest or need:

- CPR/AED/First Aid Course, online – 4 credits
- CPR/AED/First Aid Course – 4 credits
- CPR/First Aid Course Train-The-Trainer – 16 credits*

**These courses require additional commitments such as teaching a minimum number of times per year, as well as purchasing instructor or student materials.*
