HAZWOPER 24-Hour Hazardous

Materials Technician Training

OSHA 10-Hour General Industry

Course Length: 10 hours

The OSHA 10-hour training program provides entry level general industry workers information about their rights, employer responsibilities, instructions to file a complaint and how to identify, abate, avoid and prevent job related hazards on a job site.
